**MEMORANDUM OF ASSOCIATION**

The society named SHREE MURLI MANOHAR THATHERAN PANCHAYATI MANDIR & DHARAMSHALLA SAMITI, BHIWANI was constituted and got registered in 1980 vide Registration No. 346 of 1980-81 dated 13.10.1980 by 13 founder members as subscribers to the Memorandum of Association of the society and the following particulars were given at that time in 1980 in the Memorandum of Association as under:

**A. Name:**

The name of this Society shall be: SHREE MURLI MANOHAR THATHERAN PANCHAYATI MANDIR & DHARAMSHALLA SAMITI, BHIWANI

**B. Office:**

The Head Office of the society shall be in the State of Haryana in Bhiwani city in the premises of Murli Manohar Thatheran Panchayati Dharamshalla, Bhiwani.

**C. The aim and objects:**

The aim and objects of this society were mentioned therein in 1980 which have been taken further in the present MOA also.

**D. The list of the then Executive Committee of 1980:** The list of the then Executive Committee of 1980 alongwith the names addresses, occupation and designation of the member of the Executive Committee to whom the management of the affairs of the society was entrusted were mentioned therein in the MOA.

**E. The subscribers of the MOA of 1980:** The then office bearers and members of the society had subscribed the MOA and the same were signed by the witnesses also. The names and particulars of the subscribers and witnesses are given below:

**a) The aims and object of the society which were in the MOA of 1980**

1. श्री मुरली मनोहर ठठेरान पंचायती मन्दिर धर्मशाला का निर्माण करना, उसका प्रबन्ध एवं संचालन करना। इसके लिए धन इकट्ठा करना एवं उसका भवन निर्माण एवं मन्दिर एवं धर्मशाला के प्रबन्ध एवं दूसरे संचालन कार्यों में व्यय करना।
2. मन्दिर और धर्मशाला की उन्नति और प्रगति एवं बढ़ोतरी करना मन्दिर, धर्मशाला के लिए क्वाटर आदि का निर्माण करना एवं उनका प्रबन्ध एवं देखभाल करना।
3. बिरादरी एवं जनसाधारण के प्रयोग एवं उपयोग के लिए धर्मशाला एवं मन्दिर एवं उनसे सम्बन्धित अन्य भवन एवं सम्बन्धित प्रबन्ध करना एवं देखभाल करना तथा मानव जाति के कल्याण के लिए कोई साहित्यिक, शिल्ली, व्यापारिक, औदयोगिक, वैज्ञानिक और सदाचार की शिक्षा का प्रचार एवं शारीरिक एवं आत्मिक व सामाजिक व आर्थिक विकास के लिए आवश्यक कार्य करना एवं योग्य तथा अधिकारी बालक, बालिकाओं को छात्रवृत्तियाँ, मासिक धन सहायता और अन्य सुविधाएँ प्रदान करना। कोई विद्यालय, महाविद्यालय, पुस्तकालय, क्रीडा संस्थान और औषधालय आदि निर्माण करना एवं आवश्यकतानुसार चलाना व प्रबन्ध करना एवं या किसी ऐसी संस्था का कार्य-भार सम्भालना तथा इसकी सहायता करना।

**b) In the Memorandum of Association 1980 the following condition were also mentioned.**

- 1— आय, सम्पत्ति, भण्डार, संयत्र, ट्रेडमार्क, भूमि तथा स्थलों का प्रयोग केवल संगठन के उद्देश्यों और लक्ष्यों के उन्नत करने के लिए किया जायेगा और उसका कोई भी हिस्सा मैनेजिंग कमेटी श्री मुरली मनोहर ठठेरान पंचायती मंदिर धर्मशाला समिति के सदस्यों के प्रत्यक्ष अथवा अप्रत्यक्ष ढंग से लाभांश, बोनस अथवा लाभ के रूप में नहीं दिया जावेगा।

2— समिति के सदस्य किसी पद पर वेतनभोगी नहीं होंगे जिनका अभिप्राय यह है कि किसी भी सदस्य को पारिश्रमिक नहीं दिया जावेगा परन्तु फुटकर खर्चों उधार ली गई राशि पर ब्याज अथवा समिति को पट्टे पर दिये गये परिसर के किराये की अदायगी की जायेगी।

3— श्री मुरली मनोहर ठठेरान के पंचायती मंदिर धर्मशाला समिति, भिवानी के नाम पर प्राप्त सारी निधियाँ केवल उसके उद्देश्यों और लक्ष्यों को बढ़ावा देने के लिए प्रयोग की जायेगी।

4— श्री मुरली मनोहर ठठेरान पंचायती मन्दिर धर्मशाला समिति भिवानी का समापन होने पर सारे ऋण और दायित्व निभाने के पश्चात् जो भी सम्पत्तियाँ होवे समिति के सदस्यों को नहीं दी जायेगी अथवा उनमें बाँटी नहीं जावेगी। परन्तु वे कार्यकारिणी के निर्णय के अनुसार इसी प्रकार के उद्देश्यों वाली किसी अन्य समिति को हस्तान्तरित कर दी जावेगी। कार्यकारिणी के वर्तमान सदस्यों के नाम, पते और व्यवसाय पद नाम जिन्हें समिति का कार्य या प्रबन्ध सौंपा गया है जैसे कि सोसायटी पंजीकरण अधिनियम 1860 की धारा 2 के अन्तर्गत आवश्यक है।

**C) Now in the present Memorandum of Association the Aims and objects and other necessary provisions required for the MOA are taken, in addition to above aims and objects and conditions of 1980, herein as under as per The Haryana Registration & Regulation of Societies Act 2012 & Rules framed there under and the Model MOA which are as under:  
As per section 6 of the HRRS Act 2012:**

- (i) promotion of charity or any philanthropic activity;
- (ii) promotion of arts, education, science, literature, philosophy, religion, industries, skill development, fine arts, etc.;
- (iii) promotion of sports (excluding games of chance);
- (iv) promotion of folk arts;
- (v) promotion of artefacts and handicrafts;
- (vi) instruction and diffusion of any useful knowledge;
- (vii) diffusion of political education;

- (viii) establishment or maintenance of libraries or reading rooms for general public use, or of public museums and galleries of painting and other works of art;
- (ix) promotion of conservation and proper use of natural resources such as land, water, forests and wildlife, and optimal use of infrastructure facilities like roads, power, eco-friendly initiatives and such other resources and infrastructure facilities, as may be notified by the Government, from time to time;
- (x) formation of associations of flats or tenement or condominium or floor space owners pursuant to the requirements as laid down under the Haryana Apartment Ownership Act 1983 (Act 10 of 1983) or a welfare organization formed for housing projects or a resident welfare organization for the operation, management and maintenance of facilities for the residents or civic amenities of any defined area;
- (xi) the collection of natural history, mechanical and philosophical inventions, instruments or designs etc; and
- (xii) implementation and promotion of any Government sponsored schemes in the State:

Provided that no Society shall be registered under the Act unless it prohibits the payment of any dividend or distribution of any assets, income or profits to its members or their dependents or legal heirs except where a Society has been formed or established by the contributions of share holders or members in the nature of a housing Society or a welfare association of flats or tenement or floor space owners pursuant to the requirements laid down under the Haryana Apartment Ownership Act 1983 (Act 10 of 1983) or a resident welfare association for the operation, management and maintenance of facilities for the residents or civic amenities of any defined area.

**d) As per model memorandum of association**

- i) Promotion of national unity and international peace and amity;
- ii) Promotion of communal and social harmony and brotherhood;
- iii) To work for the cause of enforcement of prohibition and initiate people's movement against smoking, alcoholism and drug abuse;

- iv) To create awareness and addressing some of the social evils, such as, female foeticide, dowry, extravagant expenditure on social functions like marriages, empowerment of women in decision making etc.
- v) Promotion and progress of agriculture and animal husbandry.
- vi) To take up programmes for accelerating the pace of rural development with application of science and technology (techniques and technologies for cost reduction, improving, productivity etc.) especially in the field of water conservation, sanitation, low-cost housing, agriculture and animal husbandry and engineering sources;
- vii) To take up programmes for ensuring protection of environment and for regeneration of natural resources degraded due to past neglects;
- viii) Promotion and extension of appropriate technology including systems have renewable sources of energy;
- ix) Promotion of cottage and small scale industries by taking up action research work;
- x) To take up programmes in which science and technology may have major role in improving life, working conditions and opportunities for gainful employment of women.
- xi) To engage in delivery of citizen services in a transparent manner with use of Information and Communication Technology.
- xii) To undertake impact evaluation of economic and social projects.
- xiii) To undertake programmes which ensure raising of income levels and expanding employment opportunities of the weaker sections of the Society, particularly of those living below the poverty line and women by involving participants in the planning, implementation and maintenance of activities taken up.
- xiv) To organize disadvantaged section of Society and take steps for increasing their level of awareness in regards to the programme contents and facilities therein under Government/non-Government programmes, legal provisions, etc. and also for increasing their bargaining power by promoting co-operative and group action.
- xv) To take up all formal and non-formal educational programme as per directives contained in the National Policy of Education, 1986.
- xvi) To work for promotion of sports and health care activities.

xvii) To raise or acquire funds or property from Central Government, State Government, Non-government agencies, charitable trusts by way of donations or grants or contribution or by taking loan from public and private financial institutions. The funds, properties, assets and all other resources, present and future, of the Society shall be utilized for any or all the purposes or objects of the Society as stated above and also for all other similar activities in furtherance of ideals of truth and non-violence.
